## Warning: Be Careful to Purchase Diabetic Test Strips Only From Authorized Distributors





Diabetic test strip manufacturers routinely monitor pharmacy purchase history to ensure purchases only from their authorized distributors. For example, diabetic test strip maker, LifeScan, has engaged a law firm to send demand letters to pharmacies accusing them of failing to purchase test strips only from its authorized distributors. In addition to threatening to inform PBMs of the accusation (which may lead to the pharmacy's termination from the network), the law firm has also demanded tens of thousands of dollars. Note that some PBM contracts require dispensing only diabetic test strips from the maker's authorized distributors. To avoid these accusations, when purchasing diabetic test strips make sure to utilize only the manufacturer's authorized distributors.
